
ORDER ON COLLECTION OF LAW LIBRARY FEES

Pursuant to OCGA §36-15-9 and for the purpose of providing funds for specified uses pursuant to OCGA §36-15-7 the Court hereby increases and ORDERS the fee to be collected in all proceedings of a civil, criminal or quasi-criminal nature in the Superior Court of Columbia County and the Probate Court of Columbia County be set at four dollars (\$4.00) per filing beginning July 1, 2023.

The Clerk of Superior and Probate Court "shall collect such fees and remit the same to the treasurer of the board of trustees of the county law library...on the first day of each month." OCGA §36-15-9(a).

It is further ORDERED that this Order be filed with the Clerks of Superior and Probate Courts of Columbia County, Georgia.


